2. Personal data

In connection with establishing and managing membership in the association DKE-Data agrirouter e.V., we collect the following personal data about you:

- your contact details such as your name, business address, business phone number, and business email address;
- type of your membership; and
- other personal data that we process in connection with establishing and managing the membership in the association DKE-Data agrirouter e.V.,

3. Purposes of the processing of personal data and its legal bases

In the context of the membership relationship, we process personal data for the following purposes:

• Establishing and managing the membership relationship. The legal basis for this is Article 6 (1) (b) or Article 6 (1) (f) GDPR (the latter in case you are staff of a

member). The collected data is mandatory for the establishment and/or management of the membership relationship.

- Communicating with you with respect to your relationship as a member, e.g. on important technical developments or interruptions of the DKE Connectivity Platform. The legal basis for this is Article 6 (1) (f) GDPR, as we share the same interest in keeping you up-to-date.
- Compliance with our legal obligations, such as commercial and tax laws. The legal basis for this is Article 6 (1) (c) GDPR.
- Asserting or defending against legal claims in case of a legal dispute. The legal basis for this is Article 6 (1) (f) GDPR.

4. Recipients and/or categories of recipients of personal data

The personal data will be disclosed to the chairman, who shall use them within the scope of fulfilling its obligations set out in the articles of association.

We may transfer personal data to our service providers and professional advisors, public and governmental authorities. For example, we may share personal data with third-party service providers that provide services to us, including billing, payment processing, data hosting, auditing, and data processing.

We may also transfer your personal data to DKE-Data GmbH & Co. KG, Albert-Einstein-Str. 42, 49076 Osnabrück / Germany (hereinafter refers to as the "**KG**"), where this is necessary for the purposes of managing the membership relationship, including for the making available of information that is relevant for our members (in particular on the website https://agrirouter.com/). Together with us, the KG is a joint controller in accordance with Article 26 GDPR, as the KG jointly determines the purposes and means of the processing in the context of the membership (e.g. agrees with us on the scope of the data processing). We have concluded an agreement of joint controllership with the KG, essentially determining that we act as your central point of contact with respect to any processing of personal data for membership purposes.

5. Transfer of personal data to third countries

Generally, we do not transfer personal data outside of the EU/EEA.

6. Period for which personal data will be stored

We process and store your personal data during the membership, and after the termination and settlement of your membership as long as required to fulfil our legal obligations (e.g. under tax or commercial law) or to be able to provide evidence as long as legal claims can be brought against us. We delete personal data if it is no longer required for these purposes.

7. Your rights under the GDPR:

- Right of access (Article 15 GDPR)
- Right to rectification (Article 16 GDPR)
- Right to erasure (Article 17 GDPR)
- Right to restriction of processing (Article 18 GDPR)

- Right to data portability (Article 20 GDPR)
- Right to object (Article 21 GDPR)
- Right to file a complaint to the responsible supervisory body
- If the data processing is carried out with your consent, you can revoke this consent at any time and without giving reasons. Please note that such a revocation will only be effective for the future and does not affect the lawfulness of the data processing for the past.

8. Obligation to provide personal data

There is no obligation for you to provide us with personal data. Please note that we cannot establish and manage the membership in DKE-Data agrirouter e.V. without processing of your personal data.

9 Automated decision making

We do not use automated decision making falling under Article 22 GDPR.
